It shall include cost of material, import duties, other duties & taxes, VAT, works contract tax, Service Tax, all cess, tools and plants, transportation, freight, insurance, storage, incidental expenses, loading/unloading, shifting in position with required hoists and equipment, scaffolding, labour, night labour, wastage, contractor's profit, installation, testing, commissioning and other works required.

19.	'Performance Security' during warranty period	10% of the total executed value in the form of Bank Guarantee from nationalized bank shall be submitted along with final bill and shall be valid throughout the warranty/ defect liability period.

The tenderer should possess latest valid Solvency Certificate from a nationalized / scheduled bank for an amount not less than Rs. 40 lakhs. 4.
